#### Subject of the Disclosure

Petrolueum Exploration Drilling at Hawkeye-1 thru Service Contract 55 - Southwest of Offshore Palawan

#### **Background/Description of the Disclosure**

The Company thru its subsidiary, Pryce Gases, Inc. ("PGI"), received the following information from Otto Energy Philipines, Inc., ("Otto") that drilling at Hawkeye has reached final depth of 2,920 metres. Otto further informed PGI that: "The well intersected hydrocarbons in the initial 30 metres of the reservoir interval and then drilled through some good quality sands that were water bearing. Based on this information, the Hawkeye structure, although containing a hydrocarbon discovery, would be too small to be economic. The plan in the coming few days is to plug and abandon the well and to release the drilling rig to return to Malaysia."

PGI entered into a Farm-In Agreement with Otto to acquire from the latter ten percent (10%) participating interest in Service Contract 55 (SC 55) of the Philippine Government through the Department of Energy.
